## WHAT DOES SPC Credit Union DO WITH YOUR PERSONAL INFORMATION?

### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

#### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and Income
- Account Balances and Payment History
- Account Transactions and Credit History

#### How?

All financial companies need to share  $_{\rm members'}$  personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons SPC Credit Union chooses to share; and whether you can limit this sharing.

For our everyday business purposes— such as to process your transactions, maintain your account(s), respond to court orders and legal investigations, or report to credit bureaus	Yes	No

How does SPC Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.  SPC regularly tests and assesses its information security measures and adopts upgrades and enhancements as necessary.

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.

Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
	The nonaffiliated we share with can include insurance compianies, data processors, check printers, consumer reporting agencies, statement printers, mail houses and plastic card processors
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
